


Workforce Size in Sheridan County

Top Employing Industries, 2023




Percent of Total Employment

Labor Force Participation


- **61.1%** of Sheridan County's population over 15 participates in the labor force, similar to the statewide rate of 63.0%.

Sheridan County had **30 more people move out** than in from 2020 to 2023.


4.9% of workers in Sheridan County **work from home**, less than the statewide average of 10.6%.


Population by Age Group and Participation in Labor Force
